This update of the Saba Meeting mobile app includes the following enhancement.

Saba Video support

Prior to this update, there was no support for Saba Video in the Saba Meeting mobile app.

In this update, when a presenter is showing a Saba Video within the meeting event, all the Saba Meeting participants will be able to view this video on the Saba Meeting mobile app. This will work only on the integrated Saba Cloud - Saba Meeting environments.

The leader cannot control Saba Video for the participants. Saba Video will be available as part of the recording, but the leader controls will not be part of the recording. Saba Video will not be available to guest users.
